Regulations are in place to ensure safety and security for all products and some single use packaging materials are necessary to ensure single use and single dose of medication is accurately measured and dispensed. Packing materials allowed to be used and presentation of pharmaceuticals are controlled by our TGA registrations. This is also a constraint when it comes to innovation in the packaging materials in our supply chain.

All packaging and production is conducted outside of our local control at Norgine factories in UK and Europe. We rely heavily on Norgine Global policies for action in this regard related to our branded product packaging. SPG is not used in UK and Europe, but similar standard s apply. Norgine Business Code includes Environmental Policy Statement dealing with efficient utilisation of resources, waste management, recycling, minimising packaging, other environments issues.

APCO Action Plan Commitments

For each of the Packaging Sustainability Framework criteria listed below, a description is provided along with the commitments made by the organisation in their APCO Action Plan.

Criteria 1:

Governance & Strategy:

This criteria considers actions to integrate packaging sustainability into business strategies.

- Develop a strategy that includes goals for packaging sustainability that addresses the Sustainable Packaging Guidelines (SPGs) or equivalent.

Criteria 2:

Criteria 3:

Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Aim to use recycled materials in any packaging where this is feasible, including:
 - Primary packaging
 - Secondary packaging
 - Tertiary packaging

Criteria 4:

Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

• Investigate whether all of our packaging is recyclable at end-of-life and identify any gaps and opportunities for greater reuse or recycling.

Criteria 5: Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

• As packaging is updated or refreshed, add on-pack information for consumers on recyclability or correct disposal.

Criteria 6: On-site Waste:

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

• Develop a system to collect and recycle used packaging generated at our facilities.

Criteria 7:

Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.





- Undertake the following to help reduce the impact of litter:
 - Look for opportunities to redesign packaging to eliminate components that may have the propensity to become litter
 - Pharmaceutical products must be manufactured from original materials. All packaging and production is conducted outside of our local control at Norgine factories in UK and Europe. Regulations are in place to ensure safety and security for all products and some single use packaging materials are necessary to ensure single use and single dose of medication is accurately measured and dispensed. Packing materials and presentation is controlled by our TGA registrations.

Where possible and practical and legal under the regulations we use recycled and recyclable materials.

All packaging and production is conducted outside of our local control at Norgine factories and 3rd party factories in UK and Europe.

We rely heavily on Norgine Global policies for action in this regard related to our branded product packaging. SPG is not used in UK and Europe, but similar standards apply. Norgine Business Code includes Environmental Policy Statement dealing with efficient utilisation of resources, waste management, recycling, minimising packaging, other environments issues. Local office actions:

Paper and container recycling in place as part of building services.

Printer toner and waster cartridges are collected for recycling by supplier.

Paper and cardboard advertising materials are placed for recycling.

IT e-waste is taken to local area collection point as required.

3PL warehouse.

Plastic Wrap Excess wrap collected and recycled separately at 3PL warehouse. Bundled into bales for periodic collection. Shipper cartons Excess cardboard collected and recycled separately at 3PL warehouse. cardboard separated and

collected. Damaged and expired pharmaceutical stock requires formal destruction which is documented. No product is to go directly

into landfill waste stream without appropriate destruction (usually incineration). But this also limits the ability to recycle and reuse.

Further commitments:

These commitments look at additional actions the organisation may take to improve reporting.
